RATING RATIONALE

Agusto & Co. assigns 'Aaa (NGA)' rating to Nigeria Sovereign Investment Authority ('NSIA or the Authority') reflective of the credit rating of the Federal Republic of Nigeria (FGN) on our national rating scale. The NSIA is wholly owned by all the tiers of government in Nigeria. Given its ownership structure, we consider the Authority to be a government-backed institution. We have also assigned an ESG score of '2' denoting that environmental, social and governance issues have minimal contributions to credit risk. The assigned rating also reflects the Authority's strategic role in building a savings base for the Nigerian people, enhancing the development of Nigeria's infrastructure and providing fiscal stability in periods of economic stress. However, constraining the rating is the Authority's exposure to the Nigerian fragile macroeconomic climate though to an extent moderated by its investments in the United States treasury bills and other gilt edged securities.

NSIA was established by the Nigeria Sovereign Investment Authority Act which was signed by the former President Goodluck Jonathan in May 2011. The Authority's core mandates include building a saving base for Nigeria's future generation, enhancing the development of Nigeria's infrastructure and providing fiscal stabilisation support in period of economic stress, facilitated by funds from Nigeria's excess crude oil revenue. The Authority is jointly owned by the Federal Government of Nigeria (45.8%), the 36 State Governments (36.2%), the 774 Local Government Authorities (17.8%) and the Federal Capital Territory (0.2%). The NSIA Act incorporates best practices of the International Forum of Sovereign Wealth Funds' Santiago Principles which are a set of 24 voluntary guidelines that assign best practices for the operations of Sovereign Wealth Funds (SWFs). Nigeria's SWF was launched with a seed funding of US\$1 billion in October 2012 while an additional US\$750million (emanating from Nigeria LNG Limited (NLNG) dividends and excess crude account contribution) was injected between 2016 and 2019. However, \$150 million was withdrawn from the stabilisation fund in FY 2020 to augment the funding of the Federation's budget and to offset the impact of the fall in crude oil prices. Although contribution from the shareholders (the various tiers of governments) have been inconsistent, contrary to the specifications in the NSIA Act, nevertheless, the Authority's assets under management (AUM) have grown to

In line with the NSIA Act 2011, governance is vested with the Governing Council and the Board of Directors. The appointment of the Board of Directors and the Chief Executive Officer is approved by the President of Federal Republic of Nigeria. During the year under review, a new Board of Directors (the third since the inception of the Authority) was inaugurated on 1 September 2021 as the tenure of the prior Board ended in May 2021. In our view, consistent changes in the Board of Directors negatively impacts seamless succession. In the near term, we anticipate further changes to the Board given the expected appointment of an Executive Director and the retirement of Mr. Uche Orji (the pioneer Chief Executive Officer) in October 2022.

Contributions from NSIA's shareholders are allocated to three ring-fenced funds, namely the Stabilisation Fund ("SF"), Future Generations Fund ("FGF") and Nigeria Infrastructure Fund (NIF). The investment philosophy for the SF and FGF (which are funds that invest in securities in multiple geographies), is to preserve value and earn decent returns. However, while the SF is invested in short term, highly liquid and good credit quality securities, the FGF is a longer tenured investor in good credit quality investments. Nevertheless, the NIF operates differently as it is entirely invested locally to drive the development of strategic domestic infrastructure and support economic diversification. In FY 2020, US\$150million of the SF was liquidated to augment the funding of the Federation's July budget and to offset the impact of the fall in crude oil prices due to the coronavirus pandemic. This was the first withdrawal by the Nigerian Government and is well within the stabilisation fund's mandate.

NSIA generates its income from treasury securities, hedge funds and dividend from investee companies such as Infracredit, Nigerian Mortgage Refinance Company (NMRC) and Family Homes Fund. In the review period, ancillary income (mainly net gains on financial assets and foreign exchange gains) accounted for 74% of operating income, while core earnings from treasury securities and fixed income products accounted for the balance of 22% and 4% respectively. Ancillary revenues dominated the operating income base in FY 2021 given

the persistent devaluation of the naira and higher closing exchange rates used in the translation of financial assets. Overall, profit before tax declined by 11% to \text{\text{\$\frac{1}}}42.6 billion while pre-tax return on average assets (ROA) and pre-tax return on average equity (ROE) reduced to 13.6% (FY 2020: 21.3%) and 17.7% (FY 2020: 24.7%) respectively. Nonetheless, we consider the Authority's profitability to be good as the ROE was slightly higher than the 17% average inflation rate recorded in FY 2021. In the near term, we expect ancillary revenue to dominate the operating income base given the prevailing devaluation of the naira. However, the rising yields across the globe – particularly on US treasury notes should cause core income to account for a greater proportion of operating earnings. Nevertheless, while profitability is not NSIA's core mandate, we believe that the Authority's performance will remain acceptable in the near term engendering a satisfactory capacity to fulfil mandates.
