



NET ASSETS

With twelve consecutive years of profitability, we have demonstrated resilience and consistency, and the ability to deliver strong financial performance while advancing high-impact investments that unlock sustainable development across priority sectors.

In 2024, we delivered our strongest financial performance to date, recording a Total Comprehensive Income of N1.89 trillion, a significant increase from N1.18 trillion in 2023. Our core Total Comprehensive Income, excluding foreign exchange derivative gains, grew by 148% to N407.9 billion, while our net assets nearly doubled to N4.35 trillion. These results underscore our ability to navigate a complex macroeconomic environment with discipline, strong governance, and innovative investment strategies. But

beyond financial performance, our mandate requires us to create an impact that serves both national development priorities and global sustainability objectives, catalysing economic activity, creating jobs, and strengthening critical infrastructure.

In 2024, we deepened execution capacity across our infrastructure portfolio, operationalising new subsidiaries such as MedServe and advancing transformative projects, including the nationwide expansion of healthcare centers and renewable energy initiatives through RIPLE, such as a 20MW solar-hydro hybrid plant in Shiroro.

We also expanded inclusive development initiatives, such NSIA Prize for Innovation, which since inception has awarded over US\$400,000 to young innovators solving local challenges with scalable solutions, and, advanced oncology training programs to strengthen the capacity of Nigeria's healthcare workforce. We set new benchmarks in climate finance and sustainability, most notably through the co-establishment of of the Green Guarantee Company (GGC), the world's first climate-focused guarantee platform, designed to unlock over US\$4 billion in

climate finance by de-risking climate projects in developing markets.

Our success lies not only in where we invest, but how we deliver. In 2024, we conducted our first carbon footprint assessment, creating a baseline for future emission reduction targets. We also initiated digital automation of key processes to improve operational efficiency, enhance data infrastructure and integrity, and strengthen performance monitoring.

The Stabilisation Fund (SF):

This fund is designed to buffer against economic volatility and stress. Through this fund, 20% of NSIA's capital is invested in short-term, low-risk investments across Hedge and Growth Assets, with a primary focus on preserving capital.



The Future Generations Fund (FGF):

This fund, being a cornerstone of NSIA's mandate for intergenerational equity, is targeted at ensuring sustained prosperity of future Nigerians through long-term investments. With 30% of NSIA's capital, this fund employs strategic asset allocation and diversification to manage volatility and macroeconomic uncertainties, aligned with its long-term investment horizon.



The Nigeria Infrastructure Fund (NIF):

With the objective of driving economic transformation through domestic infrastructure development, this fund deploys 50% of NSIA's total capital towards investments across key sectors such as energy, transportation, healthcare, and agriculture. These investments are designed to stimulate economic growth, create employment opportunities, and improve the standard of living for Nigerians. Over the years, the fund has delivered substantial social and economic impact nationwide.

Our commitment to sustainable growth is reflected in our three-fold mandate: infrastructure development, economic stabilisation, and securing prosperity for future generations. To achieve these objectives, we develop and sponsor high-priority projects and programs designed to yield long-term socio-economic benefits for the nation. Additionally, we undertake fund and project management services on behalf of the FGN.

Through our strategic investments, we aim to create a resilient and diversified economy that can withstand global economic fluctuations. Our focus on sustainability ensures that our investments not only generate financial returns but also contribute positively to the environment and society. We prioritise investments in renewable energy, sustainable agriculture, and innovation; laying the groundwork for a greener, more prosperous Nigeria.

Deep Dive into Our Investment Mandates

In line with the NSIA Act, our investments are structured across three core funds, each with a specific objective and strategic focus. These funds are separate and ring-fenced to ensure clarity and accountability.

STABILISATION FUND (SF)



Objective: To provide stabilisation support during periods of economic stress.



Allocation & Size: 20% allocation with a current size of US\$300 million.



Strategic Asset

Allocation: Primarily focuses on US Treasuries & Investment Grade Corporate Fixed Income (75% allocation) and Cash (25% allocation).



Expected Returns:

Targets US CPI.



Investment Horizon:

Short Term.

FUTURE GENERATIONS FUND (FGF)



Objective: To establish a savings base for future generations of Nigerians, ensuring financial security for when crude oil reserves are depleted.



Allocation & Size: 30% allocation with a current size of US\$1 billion.



Strategic Asset

Allocation: Invests across various asset classes including Public Equity (25%), Private Equity/ Venture (25%), Hedge Funds (17.5%), Hedging Assets (25%) and Cash & Other Diversifiers (7.5%).



Expected Returns:

Targets US CPI + 400 BPS.



Investment Horizon:

Long-term (over 20 years). This multi-asset portfolio aims for both alpha generation and downside protection.





At the heart of NSIA's mandate lies a deliberate strategy to catalyse sustainable development through targeted capital deployment, anchored on six strategic pillars: Capital Mobilisation, Capital Formation, Strategic Impact Investment, SME Development, Direct Investments, and Ecosystem Development.

This framework reflects a coherent response to Nigeria's most pressing development gaps. Each pillar serves as a lever for

systemic transformation: from attracting blended finance and fostering local capital markets, to scaling critical infrastructure, supporting homegrown enterprises, and enabling investment ecosystems. Collectively, they define NSIA's philosophy for driving sustainable national development, one that is bold, catalytic, and aligned with Nigeria's long-term socio-economic priorities.

National Investment Footprint

At the core of our mandate is the enhancement of infrastructure development and the stimulation of economic growth within Nigeria. The Nigeria Infrastructure Fund (NIF) focuses on investing in domestic infrastructure projects that align with national priorities and offer strong commercial and social returns.

NIF aims to catalyse private sector participation, both domestic and international, in infrastructure investments. We develop and sponsor high-priority projects and programs designed to yield long-term socio-economic benefits for the nation.



Africa Investment Footprint

We are actively involved in driving growth and development across the African continent, recognising the potential for regional impact and collaboration. Over the past decade, we have extended our investment footprint across more than 14 of the 54 African countries. Through these efforts, we have invested in over 150 projects across Africa in critical sectors such as renewable energy, healthcare and agriculture.

Specific countries where we have reached investments or have them in view include Morocco, Senegal, Ivory Coast, Ghana, Nigeria, Cameroon, Zimbabwe, Lesotho, South Africa, Zambia, Botswana, Egypt, Uganda, and Kenya.




Figure 5: Africa Investment Footprint

Global Investment Footprint

Beyond our domestic initiatives, we maintain a significant global investment footprint, leveraging international markets to strengthen Nigeria's economic future. Over the last decade, we have invested over US\$800 million in funds globally. As of the reporting year, our investment footprint includes 56 total funds, excluding direct investments within Nigeria. These investments are spread across various key regions worldwide, demonstrating diversified exposure.

This global exposure, particularly within the Future Generations Fund's externally managed investments, forms a crucial part of our strategy to build a robust savings base for future generations. In 2024, this diversification was further enhanced with the onboarding of six new fund managers, including one ESG-focused fund and two US-based funds.



Presidential Initiatives

NSIA has been strategically positioned by the Federal Government to implement flagship Presidential Initiatives that address some of Nigeria's most pressing developmental priorities. These initiatives; anchored in infrastructure, healthcare, and industrial development reflect NSIA's dual role as both investor and project developer, leveraging its institutional capacity to execute high-impact projects at scale.

Through a disciplined investment approach and strong governance structures, NSIA ensures that these initiatives deliver measurable value, foster inclusive growth, and align with the national vision for long-term prosperity.

Presidential Infrastructure Development Fund (PIDF)

The Presidential Infrastructure Development Fund (PIDF) was launched by the Office of the President in 2018 to fast-track the delivery of critical, high-impact infrastructure across Nigeria and stimulate economic development. NSIA was designated as the Fund and Project Manager, tasked with overseeing the financing and execution of the PIDF projects.

Key projects under the PIDF include:

- Lagos-Ibadan Expressway (LIE): A 127.6km highway serving as a major transportation artery linking the northern, southern, and eastern regions of Nigeria.
- Second Niger Bridge (2NB): A 1.6km bridge spanning the River Niger, with 10.3km approach roads connecting Anambra and Delta State, complemented by two 21.7km auxiliary bridges and an interchange.
- Abuja-Kano Expressway (AKR): Originally planned as a 92.5km rehabilitation across three sections, the project was expanded in June 2020 to a full reconstruction of the 375.9km dual carriageway, following a directive by the former President.









The Presidential Fertiliser Initiative (PFI) was established to provide Nigerian farmers with timely access to affordable, high-quality fertiliser in commercially viable volumes, while also revitalising the domestic blending industry. The program prioritises local content, with over 60% of raw materials such as Urea and Limestone; sourced within Nigeria, and production carried out at rejuvenated local blending facilities.

 $NSIA\,was\,mandated\,to\,execute\,the\,initiative, leading\,to\,the\,creation$ of a Special Purpose Vehicle, PFI-NPK Limited, to oversee and manage the entire value chain from input procurement to the distribution of blended fertiliser.

Since inception, the Presidential Fertiliser Initiative has transformed a largely dormant sector, expanding from 4 operational blending plants to 11 by 2017, and over 90 by the end of 2024; driving local production and agricultural growth.









Kano Solar Project (KSP)

The former President of Nigeria Muhammadu Buhari appointed NSIA as both the Fund Manager and Project Manager for the design and implementation of a 10MW solar power plant in Kumbotso Local Government Area, Kano State.

- As part of its mandate, NSIA was responsible for:
- Establishing a special purpose vehicle, Haske Solar Company Ltd, with an ownership structure of 80% Federal Government of Nigeria, 15% Kano State Government, and 5% Kumbotso Local Government;

- Leading all pre-development and development phases of the project;
- Bringing the project into full operation.

The project's model connects industrial users to a reliable alternative power source, while also enhancing electricity access for small and medium-sized enterprises and reducing reliance on diesel-powered generators.

The \$16 million solar facility was officially commissioned by the former President on January 30, 2023.

INSTITUTION

At the institutional level, NSIA has embedded sustainability throughout its operations by developing comprehensive policies and frameworks, including the ESGMS Manual, ESG Policy, Climate Action Policy, Development Impact Policy, and Gender Equality and Inclusion Policy. These policies are integral to our governance structure and are implemented across business units to ensure responsible practices such as sustainable procurement, energy-efficient operations, and the digitisation of processes.

NSIA also aligns with global best practices and standards, such as the UN Principles for Responsible Investment, the IFC Performance Standards, and the UN SDGs, ensuring that

all investments are aligned with sustainable development goals and deliver long-term value. Our commitment is reinforced by a dedicated ESG team that integrates sustainability into investment decisions while mitigating environmental and social risks.

Employee engagement remains a key focus for us, with initiatives like ESG Week aimed at raising awareness and driving internal adoption of sustainability principles. This includes targeted activities designed to improve understanding of ESG issues, encourage employee participation in sustainability projects, and foster a culture of responsibility and accountability across all levels of the organisation.

In addition to internal engagement, we actively encourage our employees to be part of broader community impact efforts. A prime example is the "Bottles for Books" initiative in collaboration with Chanja Datti, where recyclable waste generated within the organisation is collected and off-taken for recycling. The proceeds from this initiative are then used to support educational opportunities for children in low-income households. This programme not only promotes environmental consciousness but also strengthens our commitment to social responsibility by contributing directly to improve access to education in underserved communities.

Together, these efforts reflect our holistic approach to sustainability - one that combines internal awareness with meaningful community impact.

NSIA's transparent governance practices, recognised by rankings such as the Linaburg-Maduell SWF Transparency Index, underscore our commitment to responsible, long-term growth and set a strong precedent for fostering sustainable institutional partnerships.



INVESTMENTS

At the NSIA, we consistently seek investment opportunities that balance financial competitiveness with a commitment to global sustainability goals. NSIA has consistently sought opportunities that are both financially competitive and aligned with global sustainability goals. Notable initiatives such as the Renewables Investment Platform for Limitless Energy (RIPLE) and Carbon Vista represent ourproactive approach to tackling climate change through capital deployment in renewable energy solutions and carbon avoidance and removal projects. These investments drive Nigeria's energy transition while delivering long-term, sustainable returns.

By embedding sustainability principles and policies into our governance structures, we have streamlined internal processes and ensured that sustainability criteria are integrated into our investment appraisal models. As a result, all potential investments are assessed through

this lens to ensure alignment with our commitment to sustainable development and to minimise adverse environmental and social impacts

In addition to these initiatives, we actively engage with our portfolio companies to ensure robust ESG oversight, driving continuous improvement in their sustainability performance. To enhance transparency and accountability, we are developing and implementing a standardised framework to measure and report the sustainability performance of all investments. This collaborative approach ensures that our investments not only yield financial benefits but also contribute positively to broader ESG objectives.



PARTNERSHIPS

NSIA's approach to partnerships is equally strategic. We have aligned with key national and international stakeholders, including the National Council on Climate Change (NCCC), the One Planet Sovereign Wealth Funds network, and the Africa Carbon Markets Initiative, to support the government's climate action agenda. By leveraging these partnerships, we are contributing to the realisation of Nigeria's climate targets and ensuring that our investments are synchronised with national and global sustainability frameworks.

We also serve as members of the Intergovernmental Committee on Nigeria Carbon Market Activation Plan and the Steering Committee tasked with operationalising Nigeria's Climate Change Fund.

These roles further reinforce our commitment to shaping and implementing market-based solutions that advance Nigeria's transition to a low-carbon economy.

BEHIND THE **STRATEGY**:

Insights from the Head of Sustainability and ESG



Nana Maidugu Head, Sustainability & ESG

1. How has your ESG strategy influenced NSIA's approach to capital allocation between traditional sectors and climateresilient investments?

Our ESG strategy has fundamentally reshaped our capital allocation, particularly under the Nigeria Infrastructure Fund (NIF). While we initially adopted a sector-based model, targeting areas like healthcare, power, and agriculture; we recognised its limitations in capturing cross-cutting climate opportunities.

In 2024, we adopted a thematic investing approach, treating climate and sustainability as a distinct investment theme while still embedding ESG principles across all other thematic areas.

This now includes e-mobility, waste-to-energy, and sustainable agriculture. The move aligns our deployment of capital with high-impact opportunities and reinforces ESG as both a lens and a destination for investment.

2. How is NSIA future-proofing its infrastructure investments against climate, social, and technological disruption?

We have embedded ESG into our investment appraisal framework, extending beyond financial and technical analysis to include climate risk assessments

and environmental and social due diligence. We now evaluate both physical and transition climate risks to ensure portfolio resilience.

Social impact is assessed through our Theory of Change framework which enables structured tracking enhance infrastructure investments of outcomes. On the technology front, we are investing in digitisation and exploring Al to investment appraisals, with green building design already integrated into key.

3. How does NSIA's ESG strategy help derisk national priorities and attract private capital?

Recognising the scale of Nigeria's financing gap, we have adopted a platform-based model to crowd in capital. Initiatives such as RIPLE, Carbon Vista, the Green Guarantee Company, and the Construction Finance Warehouse Facility are designed to deploy our equity to demonstrate thebankability of projects, making them attractive to commercial investors, catalysing additional capital, and creating replicable models for investment.

Through these vehicles, we have mobilised blended finance, unlocked international partnerships, and strengthened investor confidence in Nigeria's infrastructure and climate sectors.

4. How is NSIA using its sustainability posture to influence national policy and sectoral behaviour, particularly in carbon markets and the energy transition?

We take a proactive, catalytic approach to shaping policy and sectoral norms by leveraging our credibility as both an investor and a convener. Through our role on Nigeria's Intergovernmental Committee on Carbon Market Activation, we work to embed investmentenabling principles into national frameworks ensuring alignment with Nigeria's NDCs while balancing ambition with commercial viability.

We advocate for high-integrity carbon credit systems, transparent infrastructure such as registries and exchanges, and market mechanisms that enable competitive pricing. More broadly, we contribute to critical dialogues on the Energy Transition Plan, regional taxonomy development, and climate finance architecture, bringing an investor-informed, Africa-focused perspective that bridges policy objectives with practical pathways to unlock capital and accelerate the transition.

5. What are your top strategic sustainability priorities over the next 2–3 years?

We are focused on four strategic priorities:

- Scaling Green Finance: Expanding blended finance platforms to unlock large-scale climate capital.
- Digitising ESG Oversight: Building a real-time ESG dashboard to improve performance tracking and investment decisions.
- Policy Advocacy: Contributing to national and continental frameworks, including sustainable finance taxonomies.
- Global Reporting Leadership: Aligning with ISSB standards ahead of regulation to position

These priorities aim to deepen our impact, enhance credibility, and reinforce NSIA's leadership in climate finance across Africa.

6. What challenges has NSIA encountered in scaling climate investments?

Two major challenges are:

- Data Limitations: Inadequate and inconsistent ESG data have hindered our ability to make informed decisions. We are addressing this through building our data infrastructure and management systems, as well as leveraging digital platforms that enable real-time data collection and impact tracking across our portfolio.
- Misalignment with Global Taxonomies: Nigeria's development priorities, for example the use of natural gas as a transition fuel, sometimes diverge from prevailing global green standards. While NSIA does not invest in fossil fuels, we recognise that natural gas remains critical for bridging Nigeria's energy access gap and driving industrialisation. Accordingly, weselectively support gas-related infrastructure where it demonstrably enables a lower-carbon pathway and socioeconomic development. At the same time, we actively advocate for global frameworks and taxonomies that better reflect Africa's developmental realities and uphold the principle of a just and equitable transition.

Our approach balances climate ambitions with economic development needs, ensuring that our investments remain both impactful and contextually relevant.

The Vice President Kashim Shettima on 7th March 2024, in augurated the Intergovernmental Committee on Carbon Market Activation Plan, which NSIA is a member of, in a bid to create a blueprint to drive an effcient sustainable carbon market system.

This effort, in collaboration with the Africa Carbon Market Initiative (ACMI), aims to reduce Nigeria's carbon footprint and help deliver on our Nationally Determined Contributions commitments under the Paris Agreement.






NSIA, in collaboration with SEforALL, hosted **Mr. Rajiv J. Shah, President of The Rockefeller Foundation,** and key stakeholders at a private sector roundtable in June 2024. The event focused on climate finance strategies and actionable opportunities to address Nigeria's energy gaps, aligning with NSIA's commitment to sustainable energy solutions.



NSIA, in partnership with White & Case LLP, AFC, and Afreximbank hosted the Food and Energy Security in Africa" conference and workshop in November 2024. The event facilitated high-impact discussions and stakeholder engagement on critical food and energy security issues, aligning with NSIA's commitment to sustainable development in Africa.





At the third **Annual Meeting of the Africa Sovereign Investors Forum (ASIF), NSIA engaged with African SWFs and international stakeholders** to foster collaboration on mobilising capital for scalable infrastructure and inclusive development in Africa.

This aligns with NSIA's goal to drive sustainable development through strategic partnerships.

NSIA hosted a roundtable on "Pharmaceutical Excipients Manufacturing Possibilities and Opportunities," bringing together stakeholders from pharmaceuticals, agriculture, academia, and regulatory bodies to explore manufacturing opportunities. The event fostered collaboration and innovation, aligning with NSIA's goal to advance healthcare and infrastructure sustainability in Nigeria.





NSIA, in collaboration with FIRS, NCS, and other stakeholders, hosted a workshop to advance the National Single Window (NSW) project. The workshop brought together key agencies to streamline trade facilitation in Nigeria, aligning with NSIA's efforts to foster effcient, sustainable economic development in Nigeria.





NSIA hosted the **Presidential Fertiliser Initiative (PFI) Stakeholders Roundtable**, focused on food security. The event provided a platform for discussing PFI's achievements, addressing challenges, and identifying opportunities for growth in Nigeria's fertiliser industry. Key stakeholders included governmentagencies and industry Trepresentatives, aligning with NSIA's commitment to sustainable agricultural development.





MedServe, NSIA's healthcare subsidiary, partnered with the National Institute for Cancer Research and Treatment (NICRAT) for the second Oncology Summit, focused on strengthening Nigeria's oncology workforce. The summit brought together global stakeholders to address manpower gaps incancer care. NSIA's MD & CEO emphasised strategic collaborations, policy development, and specialised training as key to improving cancer outcomes in Nigeria, reinforcing NSIA's commitment to healthcare infrastructure and medical innovation.









At the New York Climate Week, Nana Skari Maidugu, NSIA's Head of Sustainability & ESG, participated in the Bloomberg Sustainable Finance Forum. She highlighted NSIA's initiatives like InfraCredit, GGC, and the Joint Project Preparation Facility, designed to mobilise capital for infrastructure projects in Nigeria. She highlighted the need to address capital flow constraints and expand Nigeria's carbon market to attract sustainable investments.





NSIA participated in the 16th annual IFSWF meeting, hosted by the Oman Investment Authority, focused on "Embracing Disruption and Searching for Resilient Futures." MD & CEO Aminu Umar-Sadiq highlighted the importance of adaptability, innovation, and resilience in navigating policy shifts and emerging investment opportunities for long-term value creation.







The NSIA team, led by the **CEO**, engaged with the **Presidential Initiative for Unlocking the Healthcare Value Chain (PVAC)** to discuss dedicated financing platforms and strategic partnerships. This collaboration aims to accelerate sustainable growth and strengthen Nigeria's healthcare ecosystem.



To enhance ESG practices and close knowledge gaps in the Microfinance and Other Financial Institutions sub-sector, **DBN** held a technical assistance programme for its **PFIs on 14–15 November 2024.** Participants included key staff from **ESG**, **Risk Management**, and **Compliancedepartments**.

The training focused on assessing and managing ESG risks in lending, with emphasis on financing environmentally sustainable projects (e.g., renewable energy, sustainable agriculture), promoting workplace diversity and fair labour practices, and reinforcing strong corporate governance and regulatory compliance.

DBN formally signed the **Accreditation Master Agreement** with the Green Climate Fund becoming Nigeria's first to **Direct Access Entity** the fund. This is a significant milestone for Nigeria and the Bank, allowing the nation to access the largest global climate fund.

It was also an opportunity to engage with local and international stakeholders and ${\bf DBN}$ did so through bilateral and panel representations.







In 2024, Infracredit mobilised Nigeria's first blended local currency green Sukuk to finance a rural solar infrastructure project, marking a pioneering step in climate-aligned finance. InfraCredit also secured a US\$30 million RiskSharing and Blended Local Currency Co-financing Facility from British International Investment to support decentralised renewable energy projects in Nigeria in November 2024.

InfraCredit earned the **EDGE Advanced certification**, exemplifying its commitment to sustainable infrastructure. The certification reflects impressive performance, including 58% energy savings, 44% water savings, and a 53% reduction in embodied carbon in construction materials, setting a benchmark for green finance-enabled development in Nigeria.









OUR ESG FRAMEWORK:

THE ENGINE DRIVING SUSTAINABLE IMPACT

As a sovereign wealth manager, our Environmental, Social and Governance (ESG) Framework serves as the operating system that enables us to translate purpose into performance.

NSIA's ESG Management System (ESGMS) is a fully institutionalised framework integrated across the investment lifecycle from

screening and due diligence to monitoring and exits. Designed to align with global standards such as the IFC Performance Standards and 2X criteria, the ESGMS empowers our investment teams to make decisions that reflect both financial and non-financial risks and opportunities.



Through this framework, we evaluate every prospective investment not only for return potential but also for its environmental and social footprint, governance structure, and resilience to systemic risks, including those posed by climate change. The ESGMS also reflects NSIA's dual investment execution model, enabling rigorous ESG oversight across both directly managed and externally managed portfolios.

Driving Accountability and Adaptive Governance

Implementation of the ESG framework is institutionally anchored. The NSIA Board provides oversight, with executive accountability residing with the CEO, and operational leadership with the Head, Sustainability and ESG. Each functional team; investment, risk, legal, HR, and audit has define responsibilities to ensure ESG ownership across the organisation.

This integrated governance structure is reinforced through mandatory ESG training programmes for staff and portfolio companies, grievance mechanisms, and continuous monitoring and reporting protocols. Regular third-party audits, stakeholder feedback loops, and dynamic risk assessment tools ensure that the ESGMS remains agile and performance-focused.

In 2024, the Government Relations unit organised a five-day strategic retreat in Morocco with the Senate Committee on Finance, which oversees NSIA. The programme deepened the Committee's understanding of Sovereign Wealth Fund operations and enabled meaningful engagement with NSIA Discussions covered NSIA's investment strategies, global SWF practices, and key sectors like agriculture, ports, and

private equity. Activities included site visits to OCP's phosphate complexes, engagements with Ithmar Capital, and visits to Moroccan institutions. The retreat strengthened ties with the National Assembly, highlighted strategic partnerships, and reinforced NSIA's commitment to transparency, collaboration, and capacity-building.





FOCUSING ON WHAT MATTERS MOST:

OUR MATERIALITY PRIORITIES

Identifying what matters most is central to how we deliver long-term value. At NSIA, our materiality priorities reflect a clear understanding of the sustainability issues that intersectmost significantly withour mandate, investments, and stakeholder expectations.

Grounded in a disciplined and data-informed process, these priorities serve as a compass, shaping how we allocate capital, manage risks, and unlock opportunities across our investments.

They form the backbone of our sustainability strategy, ensuring our efforts remain focused, impactful, and aligned with national and global development agendas.

For the 2024 Sustainability Report, we undertook a comprehensive revalidation of the material sustainability issues identified in our 2023 Sustainability Report.

This process was driven by the need to ensure that our priorities remain closely aligned with NSIA's evolving business strategy, stakeholder expectations, industry dynamics, and global sustainability benchmarks.

Our approach combined internal stakeholder engagement with a structured analysis of sector trends, peer practices, and leading reporting frameworks. The objective was to reaffrm the issues that have the greatest relevance to our operations and the most significant impact on the Nigerian economy, society, and environment.

To guide this assessment, we applied a set of criteria to evaluate each topic across both its positive and negative dimensions:

The degree of benefit or harm NSIA's activities may generate for people, the economy, or the environment.

The breadth or reach of the impact, whether localised or widespread



Our 2024 materiality assessment identified six priority topics as having the highest impact on NSIA's ability to deliver long-term value and fulfill its mandate.

These topics sit at the intersection of strategic relevance and stakeholder concern, reflecting where our actions can generate the most meaningful outcomes.

Market Intelligence is critical to navigating dynamic economic conditions and identifying investment opportunities that align with national development goals. It informs our strategy, sharpens our foresight, and enhances our responsiveness to emerging risks and trends.

Economic Performance underscores our commitment to driving financial sustainability—not only for the Authority but for the broader Nigerian economy. It captures our role in capital preservation, wealth creation, and sustainable development.

Corporate Governance remains a foundational pillar of our operations. Strong governance structures ensure accountability, transparency, and effective risk oversight across our investments and subsidiaries.

Training & Education supports the continuous development of our workforce and broader ecosystem. By building capacity within and beyond the organisation, we contribute to a more resilient and skilled investment environment.

Health & Safety reflects our duty of care across all touchpoints, particularly in infrastructure and health-care sectors where we have a direct impact on human well-being.

Investment Performance speaks to our core mandate: achieving sustainable financial returns while contributing to Nigeria's economic transformation. It integrates ESG considerations into portfolio decisions and reinforces our role as a catalyst for inclusive growth.

Together, these topics anchor NSIA's sustainability agenda and guide our decisions in a way that is strategic, responsible, and impact-driven.

Reporting Beyond the Tiers: Upholding Industry Standards

While NSIA's 2024 materiality assessment was guided by stakeholder feedback, internal priorities, and strategic alignment, it is important to recognise that materiality is dynamic—often extending beyond tier rankings. Certain topics classified as Tier 3, or "Emerging Issues", may not have scored high in the current evaluation due to their perceived immediacy or direct impact. However, in accordance with global standards such as the Sustainability Accounting Standards Board (SASB), many of these topics remain inherently material to financial institutions, including sovereign wealth funds.

Frameworks like SASB identify sector-specific topics that influence long-term value creation. For NSIA, operating at the nexus of investment, infrastructure, and development finance, topics such as climate change risks, cybersecurity, social responsibility, green investments, and ethical conduct and compliance are deemed material by industry benchmarks even when they fall into Tier 3 based on internal scoring.

These topics address systemic risks, investor expectations, and regulatory developments that shape the broader financial ecosystem. Therefore, NSIA remains committed to disclosing information on these areas, reinforcing its accountability, transparency, and alignment with evolving global standards.

Management's Role in Final Materiality Judgement

Importantly, according to GRI, while stakeholder input is essential, the ultimate decision on what is deemed material lies with management.

This reinforces that sustainability disclosures should reflect more than stakeholder rankings. They should represent the organisation's strategic judgement. For a mission-driven institution like NSIA, thismeans ensuring that disclosures capture both immediate priorities and emerging issues with long-term implications.

By choosing to report on lower-tiered but industry-relevant topics, NSIA demonstrates its commitment to responsible investing, transparency, and forward-looking governance, ensuring its reporting remains both globally relevant and strategically anchored.





FROM POLICY TO PRACTICE:

Embedding Ethical Leadership in Governance Structures

Ethical leadership is central to how we operate. As an institution managing public funds, we are held to the highest standards of accountability, integrity, and transparency. These are not abstract ideas, but practical commitments reflected in our governance structures and day-to-day decisions.

This section outlines how NSIA embeds ethical leadership across key areas of governance: risk management, corporate governance, ethical data usage, cybersecurity, ethical conduct & compliance, transparency, and accountability. Each area represents a critical pillar in strengthening institutional trust, enhancing resilience, and reinforcing our long-term commitment to responsible investment and national development.

Risk Management


Risk management is a strategic enabler integrated into how we invest, operate, and govern. Our Risk Management Framework ensures that risks are identified early, assessed rigorously, mitigated appropriately, and monitored continuously.

In 2024, we maintained a disciplined approach to managing market, credit, operational, political, and strategic risks across our operations & investment portfolio. We apply the 'three lines of defense' model, where frontline teams own risk, Risk and Compliance oversee implementation, and Internal Audit provides independent assurance.

The Board regularly reviews risk appetite thresholds, with escalation protocols for material exposures. Risk mitigation strategies, ranging from avoidance and reduction to transfer, are aligned with impact levels and probability assessments.

Our risk governance strikes a balance between growth, control, and transparency, while enabling effective decision-making. Oversight is provided through dedicated Board Committees, with roles detailed in their respective charters.

The diagram below outlines the structure of the Risk & Compliance Management Function.



Corporate Governance

Robust corporate governance is fundamental to safeguarding public trust, protecting capital, and delivering long-term value. Our governance structure reflects the Authority's commitment to disciplined investment, prudent risk management, and ethical leadership.

Operating with a three-tier management system, our governance framework consists of the Governing Council, an independent Board of Directors, and the Executive Management:

In August 2024, the Federal Government inaugurated the new Board of Directors of the NSIA, mandating them to play a pivotal role in driving sustainable economic growth.



GOVERNING COUNCIL

The Governing Council offers strategic advice to the Board but does not participate in operations or oversight.

BOARD

The Board is responsible for the attainment of the objectives of the Authority, policy-making, and general supervision of the management and affairs of the Authority, as well as providing strategic guidance to the Executive Management. The Board is independent in the exercise of its statutory functions.

EXECUTIVE MANAGEMENT

The Executive Management led by the MD & CEO is responsible for implementing the policies formulated by the Board, the day-to-day management and operations of the Authority, and such other functions as may be delegated by the Board.

Ethical Conduct and Compliance

In 2024, we took significant steps to strengthen our compliance framework, promote transparency, and uphold the highest standards of integrity across our operations. Notably, the full ratification of all compliance policies by the Board reaffrmed our institutional commitment to accountability and underscored the centrality of compliance to our operations.

 $The \ Compliance \ Department \ advanced \ key initiatives, including:$

- Compliance risk assessment across all departments;
- Launch of a whistleblowing program; and
- Implementation of Anti-Money Laundering (AML) and KYC processes to improve vendor and partner due diligence.

During the reporting year, policies covering anti-bribery, corruption, and compliance risk management were actively enforced.

Technology continued to drive our approach, with enhancements to the Quality Improvement & Control platform (QIC), use of sanctions screening tools, and progress toward deploying an integrated Compliance Management System. The Compliance & Internal Audit teams maintained responsiveness, supported by regular stafftrainings and risk champion networks across departments.

Complementing these efforts, the Internal Audit unit delivered a comprehensive risk-based audit plan covering financial, compliance, IT, and ESG domains.

The team shifted beyond traditional audits, offering actionable process improvement recommendations and working collaboratively with departments to enhance internal controls. Each audit outcome was fed into NSIA's institutional risk register, ensuring better alignment between audit insights and enterprise risk management. The Risk and Compliance Unit played a pivotal role in NSIA's initial implementation of Internal Controls over Financial Reporting (ICFR), in preparation to assume full ownership from 2025. The financial year closed with zero regulatory penalties and an unqualified audit opinion which reaffirmed our financial governance strength.

Priorities for 2025 include full deployment of the Compliance Management System, expanded audit coverage including ESG and cybersecurity, and enhanced use of analytics for real-time risk monitoring. Continued investment in capacity building, particularly in ESG, IT audit, and data science, will further strengthen NSIA's ability to uphold the highest standards of ethics and compliance in a dynamic operating environment.

Transparency and Accountability

Transparency and accountability remain fundamental to our institutional integrity and governance culture. In 2024, we continued to strengthen these values through robust mechanisms that empower stakeholders to voice concerns and report potential misconduct in a safe and confidential manner.

Central to our approach is a comprehensive Whistle-blowing Policy designed to uphold zero tolerance for fraud, unethical behaviour, and any form of misconduct across NSIA and its subsidiaries. This policy offers multiple secure and anonymous channels (internally and externally managed) to encourage timely disclosures without fear of retaliation. Our outsourced platform, Tip-Offs Anonymous (TOA), ensures strict confidentiality and reinforces trust in our systems.



The framework empowers employees, contractors, consultants, and other stakeholders to report malpractice responsibly and without reprisal. All reports are treated with utmost confidentiality, and whistle-blowers are protected from retaliation under a strict non-retaliation policy, overseen by Human Resources and the General Counsel.

The governance of our whistleblowing policy is anchored within NSIA's Enterprise Risk Management structure. The Head, Risk and Compliance is responsible for policy implementation and review, with oversight by the Board of Directors. All policy updates, violations, and investigations are escalated to Executive Management and the Board for accountability.

Ethical Data Usage

In 2024, we continued to uphold the highest standards of data ethics through a robust Information Security Management Framework (ISMF) that governs how we collect, store, manage, and utilise information.

Our data governance approach extends across all NSIA operations, including our subsidiaries, investment vehicles, and portfolio companies. It ensures that both financial and non-financial data used in evaluating ESG risks, assessing climate exposure, and monitoring investment performance are handled responsibly and securely.



CONFIDENTIALITY

NSIA maintains strict controls to protect sensitive and proprietary information from unauthorised disclosure or misuse. Role-based access, secure authentication protocols, and third party-managed whistleblowing and reporting systems are among the tools deployed to uphold this principle

INTEGRITY



Ensuring the accuracy, consistency, and reliability of data—whether in investment analysis, ESG scoring, or financial disclosures—is central to our decision-making process. Our systems are designed to prevent data manipulation and support audit trails across all critical applications.

AVAILABLILITY

In line with our business continuity and risk management objectives, NSIA ensures that relevant data is accessible to authorised users when needed, particularly in relation to timely portfolio oversight, due diligence, and sustainability reporting.



In 2024, we also strengthened system safeguards against evolving cybersecurity risks, including implementing two-factor authentication for privileged user accounts, refining user access protocols, and enhancing our capacity to detect and respond to information security threats.



We believe that meaningful social progress must be inclusive, equitable, and far-reaching. In 2024, we strengthened our commitment to social responsibility by focusing on initiatives that empower our people, foster safe and supportive work environments, and drive positive outcomes for communities across Nigeria.

Training and Education

We are reinforcing our commitment to building a resilient, future-ready workforce through a series of strategic training and education initiatives. These efforts are not only strengthening our internal capacity but also contributing meaningfully to national development by investing in human capital across key sectors.

The NSIA Young Leaders Program (NYLP), formerly the Graduate Analyst Programme (GAP) is our flagship graduate development initiative. Since its inception in 2021, we have prioritised nurturing a new generation of investment professionals by equipping promising Nigerian graduates with the technical expertise and strategic insight required for leadership in the finance and investment space. We are continuously enhancing the NYLP with strengthened training modules, a well-structured succession plan, and an upgraded performance management framework.

We maintained biannual performance evaluations across all staff levels, including executives, reinforcing accountability and continuous improvement. During the year, we conducted a total of 61 staff appraisals, reaffirming our commitment to high performance, transparency, and accountability.

Within the organisation, we are prioritising internal learning and leadership development. Our introduction of a structured executive education programme in partnership with Lagos Business School is marking a major milestone, with over 10 senior staff members currently enrolled. This initiative will ultimately enhance strategic leadership capabilities, preparing our management for the evolving demands of the future.

More broadly, our employees benefit from a blend of formal and informal training interventions, averaging 54 out of 80 planned training hours in 2024. Key teams, including the NIF unit, are participating in targeted in-house sessions, while

our biannual knowledge-sharing forums are promoting institutional learning and operational continuity.

A cross-functional training series for Heads of Units was conducted to foster peer-to-peer mentoring, strategic knowledge sharing, and leadership alignment. This initiative breaks down operational silos, deepens enterprise-wide understanding, and drives consistent application of best practices across the organisation.

In parallel, through MedServe and in collaboration with our international partners, we are addressing the skills gap in the oncology value chain by launching a nationwide healthcare training programme. This immersive, hands-on initiative is training monthly cohorts of 16 clinicians - including doctors, lab scientists, nurses, radiographers, therapists, and medical physicists - through eight-week sessions at our healthcare facility in Lagos. We are targeting the training of approximately 500 clinicians over a three-year period, establishing this as one of our most ambitious sectoral capacity-building programmes to date.

To meet emerging regulatory and sustainability standards, we delivered foundational training on the IFRS Sustainability Standards to our finance team in preparation for early adoption. We have scheduled organisation-wide training for the coming

year and are implementing a six-month internal knowledge-sharing cycle to ensure sustained readiness. Through these actions, we are taking a forward-looking and proactive approach to compliance and sustainability integration.

These initiatives underscore our unwavering commitment to cultivating a resilient, future-ready workforce. By investing in comprehensive training and education programs, we are not only enhancing our internal capabilities but also contributing significantly to national development through strategic human capital investment.

Occupational Health and Safety

Our commitment to Occupational Health and Safety (OHS) remains unwavering, as we recognise that a secure workplace is not only essential for employee welfare but also fundamental to our long-term operational success.

We have implemented and continually improve a comprehensive OHS Management System in alignment with ISO 45001:2018. This system is fully integrated into our core business processes.

Our OHS framework goes beyond legal compliance, proactively identifying and mitigating potential hazards. We empower our workforce through targeted OHS training led by certified professionals, enabling early hazard recognition and accident prevention. All training and awareness activities are documented and retained as evidence of compliance and continuous learning.

In 2024, we are proud to report zero work-related injuries or illnesses, reinforcing the effectiveness of our OHS system and the diligence of our teams across all levels. In terms of trainings, 63 employees were trained on OHS in 2024.

Diversity, Equity and Inclusion



Social Responsibility - A Responsibility to One's Community

Our approach to social responsibility is embedded in our investment philosophy, operational strategy, and national development agenda. As a sovereign investment authority, we recognise our unique role in fostering inclusive growth and delivering long-term social value for Nigerians.

Our operations are designed to ensure there are no direct or indirect negative impacts on local communities. Every project

undergoes a rigorous Environmental, Social, Governance (ESG) due diligence process before approval. This includes the development of Environmental and Social Action Plans (ESAPs) to address identified risks, and continuous monitoring to ensure ongoing compliance with both local and international standards.

Through the Nigeria Infrastructure Fund (NIF), we have prioritised socially responsible investments with significant community benefits: Infrastructure projects have expanded access to education, healthcare, and clean water, especially in underserved communities.

Our healthcare investments have made a profound impact:



Cancer patients treated by The NSIA-LUTH Cancer Centre (NLCC), offering advanced and affordable care that reduces reliance on medical tourism.





Over 224,000 individuals screened for early disease detection facilitated by Kano (NKDC) and Umuahia (NUDC) diagnostic centres









These centres have collectively created over 200 direct employment opportunities and have contributed to indirect employment across their local value chains. Our goal is clear: to deliver measurable, lasting social value that improves lives, supports communities, and shapes a sustainable future for Nigeria

The NSIA-LUTH Cancer Centre marked World Cancer Day and International Childhood Cancer Day in 2024 with a strong call for early detection and timely treatment. As part of the observance, the Centre hosted a World Cancer Day Awareness Walk, uniting patients, survivors, caregivers, and advocates in a show of solidarity and shared purpose.









Medserve Strengthening Local Capacity through Clinical Trials Training

Medserve organised a 4-day clinical trials training program in Kano and Lagos led by Dr. Kunle Oshin of Worldwide Clinical Trials, USA. A total of 95 healthcare professionals were trained from partner institutions including personnel across MedServe centres.









DBN's World Environment Day 2024

Celebrating the global theme Land Restoration, Desertification and Drought Resilience, DBN partnered with the Nigerian Conservation Foundation to plant over 1000 trees across Abuja and Lagos. This initiative enabled the achievement of strategic goals by combining efforts in habitat/forest conservation, species preservation, and climate action, thereby enhancing sustainable development endeavours.



Employee Relations

At NSIA, our people are our greatest assets. We recognise that cultivating a strong relationship with our employees is essential to driving performance, nurturing innovation, and achieving sustainable national development. Our workplace culture is built on inclusion, continuous learning, well-being, and shared purpose.

In 2024, we continued to foster a supportive and empowering work environment that encourages open communication, growth, and collaboration. Our emphasis on employee engagement and satisfaction has yielded measurable results through a successful employee satisfaction survey which recorded an Employee

Net Promoter Score (eNPS) of 46, reflecting a high level of employee advocacy and satisfaction. We also recorded zero early turnover rate, demonstrating strong employee retention and satisfaction.

Our talent management approach is centered around growth. Employees are provided with learning and development opportunities linked to performance appraisals, while internal mobility remains a core pillar of our strategy. In 2024, we provided staff with the chance to explore new roles, expand their skill sets, and stay motivated.

We continue to promote work-life balance and employee wellness through:

- A parental leave policy that enables both male and female employees to care for their newborns.
- A comprehensive benefits package, including employer pension contributions, medical insurance, and group life insurance.
- Regular reviews of our offerings to ensure they remain fair, inclusive, and competitive.

As we continue to grow, NSIA remains committed to building a workplace where employees feel valued, supported, and inspired to grow. Our people-first strategy is at the heart of our mission to deliver long-term value.

Technology and Innovation

Technology and innovation are critical enablers of our mission. In 2024, our Digital Transformation Unit was established to develop and drive NSIA's digital, automation, and Al strategy, ensuring the Authority stays agile and efficient. The Digital Transformation and IT Units collaborated to modernise systems, enhance cybersecurity, and automate key workflows; advancing NSIA's evolution into a data-driven institution.

Guided by our four-year roadmap, our Digital Transformation Unit focused on reengineering internal systems to eliminate inefficiencies and reduce reliance on manual processes.

Key milestones included:

The launch of our **ESG portal**, through which all fund managers and project sponsors/developers are required to register and complete the ESG due diligence questionnaire.

The automation of core workflows such as Mail Manager and Travel Manager applications, significantly improving process speed, accuracy, and user experience.

- The development and deployment of an end-to-end Internal Audit tool, enhancing transparency, audit trail integrity, and compliance.
- The successful launch of a new procurement and vendor management platform, laying the foundation for streamlined and accountable procurement processes.

To accelerate our evolution into an insight-driven institution, we also launched an enterprise data analytics initiative. This began with a comprehensive organisational assessment to determine data readiness, process alignment, and reporting effectiveness. The initiative will guide data strategy, system integration, and insight-led decision-making going forward.


In parallel, our Information Technology (IT) unit executed a major overhaul of core systems:

- Upgrading our data center infrastructure to more energy-efficient and resilient solutions, thereby reducing downtime risk and enhancing data availability.
- Supporting **automation initiatives** by ensuring systems are optimised, secure, and scalable.
- **Driving cybersecurity awareness** through phishing simulations and an organisation-wide cybersecurity sensitisation week, positioning IT as a proactive strategic partner rather than a backend support function.

Throughout 2024, cross-functional collaboration between IT and Digital Transformation enabled a harmonised approach to digitalisation. While Digital Transformation drove business process innovation and adoption of new tools, IT reinforced the foundation through systems security, stability, and infrastructure modernisation.



These combined efforts led to measurable outcomes such as:



Looking ahead, we are working to develop an ESG Impact Dashboard to enhance portfolio oversight and track ESG performance across our investments. The tool will enable data-driven decision-making, improve accountability, and support long-term value creation for NSIA.

Procurement ESG integration

In 2024, we updated our procurement policy to embed ESG criteria. Vendors are now evaluated not only on technical merit, but also on ESG performance—measured through certifications, training, and internal policies. An automated feedback tool now captures internal user experiences with vendors, feeding into future decisions and elevating service standards.

At the operational level, a new quarterly reporting framework was institutionalised across market-facing units and extended to subsidiaries. This marks a departure from legacy self-monitoring practices, reinforcing the principle that financial support must be matched with clear, consistent reporting. Additionally, Service Level Agreements (SLAs) are being introduced across departments to define expectations and track performance via bi-annual surveys.





NSIA Prize for Innovation (NPI) 2.0

In 2024, the Nigeria Sovereign Investment Authority (NSIA) launched the second edition of the NSIA Prize for Innovation (NPI 2.0), aiming to identify, build, and finance early-stage innovative solutions that catalyse economic growth, enhance the nation's productive capacity, and create jobs. The programme awarded a combined prize value of US\$220,000 to top innovators, with Sycamore emerging as the overall winner, receiving US\$100,000.

In addition to the cash prizes, the top 10 finalists participated in a six-week, all-expense-paid program at Draper University in Silicon Valley, where they received immersive training, mentorship, and exposure to global angel investors.

NPI 2.0 has significantly contributed to Nigeria's digital economy by empowering startups with the resources and mentorship needed to scale their solutions. The initiative has strengthened the capital formation process for viable digital solutions, fostering job creation and economic diversification. This aligns with SDG 8 (Decent Work and Economic Growth) and SDG 9 (Industry, Innovation, and Infrastructure).







MedServe

In August 2024, Med Serve initiated the first phase of its healthcare expansion programme, aiming to establish 23 diagnostic centres, three additional oncology centres, and seven catheterisation laboratories across Nigeria's six geopolitical zones. The groundbreaking ceremony marked a significant step towards enhancing healthcare infrastructure and access nationwide.

This expansion is set to optimise oncology and diagnostic care in Nigeria, improving early detection and treatment outcomes. The programme is expected to create numerous direct and indirect jobs in the healthcare sector, contributing to SDG ${\tt 3}$ (Good Health and Well-being) and SDG 8 (Decent Work and








Economic Performance


For over a decade, we have maintained profitability, achieving twelve consecutive years of success, culminating in cumulative retained earnings of N3.74 trillion by the end of 2024. Operating profits rose sharply to N1.86 trillion, up from N1.18 trillion in 2023, driven by strong returns across our diversified portfolio and infrastructure assets.

Total Comprehensive Income reached №1.89 trillion, while Core Total Comprehensive Income (TCI), excluding volatile gains, grew by 148% to N407.9 billion, underscoring the resilience of our core earnings. Our total assets nearly doubled to N4.35 trillion, reflecting disciplined capital deployment and robust risk management. Beyond financial metrics, our investments have supported over 245,000 direct and 200,000 indirect jobs and catalysed billions of dollars in economic stimulus.

NSIA publishes its annual audited financial statements on its official website to ensure transparency and accountability. These financials are independently audited by a Big Four accounting firm, reinforcing the Authority's commitment to the highest standards of financial integrity and disclosure.







The NSIA Act exempts the Authority from the provisions of all taxes, fees, imports or similar fiscal laws or regulations of the Federal Government, State Government, Federal Capital Territory, Local Government and Area councils of the Federal Republic of Nigeria. The Authority is however mandated to pay tax on behalf of its employees and suppliers.

Market Intelligence

We embed market intelligence into every stage of our investment process. Our teams conduct rigorous due diligence, including ESG assessments, to ensure alignment with sustainability standards.

Sector selection under the Nigeria Infrastructure Fund is guided by commercial viability, regulatory readiness, and potential for private sector participation. We adapt our asset allocation to market conditions, adjusting exposures to hedge funds, private equity, and gold ETFs to stabilise returns.

Public-Private Partnerships

NSIA continues to leverage strategic public-private partnerships to catalyse high-impact investments across critical sectors. These collaborations have enabled us to crowd in private capital, unlock operational expertise, and accelerate the delivery of national infrastructure. In a market often constrained by fiscal limitations, our approach ensures that commercially viable projects with strong developmental value are brought to life through innovative risk-sharing and co-investment models. Below are some key partnerships in 2024:



Sustainable Finance

Launch of the Green Guarantee Company (GGC) with global partners such as the Green Climate Fund, to unlock \$1 billion in climate-aligned infrastructure quarantees.

Manufacturing

Achieved significant progress in the development of an ammonia plant in partnership with OCP Morocco.





Renewable Energy

Co-investment with North South Power (NSP) Company Ltd in developing a 20MW on-grid solar-hydro hybrid project through NSIA's renewable energy company, RIPLE.

Partnered with PASH Global to co-invest in a 2.6MWp Solar PV Plant equipped with 6MWh battery storage.

Formed strategic partnerships and advanced key projects such as a lithium battery plant and solar battery storage, through RIPLE.



Infrastructure

The Federal Executive Council in 2024 approved a landmark infrastructure financing initiative for power, toll roads, and railways. Developed by NSIA and the World Bank, it leverages sovereign guarantees to attract private investment in PPP projects. KPMG has been selected as the Project Manager.



Health

Medserve began developing 10 advanced centres across all geopolitical zones and partnered with the FMoH to expand cancer care through specialised oncology centres.

Medserve Launched a year-long oncology training program at NSIA-LUTH and signed a 10-year agreement with Varian to bring cutting-edge technology to Nigeria.

MedServe signed a US\$24.3 million mandate letter with IFC to support the healthcare expansion programme.




Investment Performance

Since commencing operations in 2012 and launching investment activities in 2013 with an initial US\$1 billion seed capital, NSIA has steadily grown its asset base through disciplined capital deployment and strategic reinvestment. Additional core contributions totalling US\$750 million between 2016 and 2020, alongside US\$221 million received between 2023 and 2024 under the Petroleum Industry Act, have brought total funding to US\$1.821 billion. Despite a US\$150 million withdrawal from the Stabilisation Fund in 2020 to support the government's COVID-19 response, our portfolio has remained resilient and growth-focused.

Stablisation Fund Net Assets and Returns

Guided by our three-fold mandate of preserving capital and driving development, NSIA has consistently delivered value through a diversified mix of medium and long-term investments. In 2024, the Nigeria Infrastructure Fund (NIF) transitioned from a sectoral investment model to a more flexible thematic approach. This shift allows us to better align capital with emerging national priorities, unlock cross-cutting opportunities, and attract like-minded co-investors.


2024 Future Generations Fund Returns



Climate Change Risks

Climate change presents both a material risk and a strategic inflection point for long-term investment. At NSIA, our mandate to deliver sustainable economic value requires a deliberate assessment of climate-related risks—particularly as they impact infrastructure resilience, portfolio performance, and national development priorities. With long-term investments at the core of our portfolio, NSIA proactively integrates climate risk across asset classes, investment due diligence, and project design.

In 2024, the Authority advanced its integration of ESG considerations across operational and investment workflows. A key milestone was achieved by the ESG & Procurement Departments, which revised the procurement policy to include ESG evaluation as a core component of vendor selection. A tailored ESG checklist is now embedded in the bid evaluation process, ensuring vendors are assessed not just on technical merit but on sustainability credentials.

Vendors with verifiable ESG certifications, structured staff training programmes, and relevant corporate policies receive competitive advantages during selection. These claims are rigorously verified using external databases and, where necessary, third-party consultants, to ensure only credible vendors are considered.

- The Risk Acceptance Criteria, which explicitly outlines excluded sectors and project types;
- The ESG Assessment Checklist, aligned with IFC Performance Standards, 2X Criteria and TCFD quidelines;
- The Project Category Evaluation Criteria, detailing ESG evaluation benchmarks by project type; and
- The full ESG Due Diligence process, which supports risk screening, categorisation, and decisionmaking.

These tools form a structured approach to identifying and mitigating climate and environmental risks across the portfolio helping us safeguard financial value while enabling sustainable development.

NSIA's role also extends to shaping national climate finance mechanisms. In March 2024, we were appointed by the Presidency to serve on the Intergovernmental Committee on Carbon Market Activation Plan. This cross-agency body is tasked with laying the foundation for Nigeria's domestic carbon market, including regulatory frameworks, market infrastructure, and institutional capacity building.

NSIA has since contributed significantly to the development of Nigeria's carbon market policy, operations manual, and associated regulations thereby positioning the country to participate more effectively in global carbon trading systems.


Through these integrated actions, both internal and system-wide, NSIA is not only managing climate risk but enabling a pathway toward climate opportunity.

Green Investments

In 2024, NSIA deepened its commitment to building a low-carbon and climate-resilient future through a portfolio of strategic green investments. These initiatives are anchored in our sustainability ethos and reflect our focus on commercially viable projects that drive economic transformation while addressing environmental imperatives.

To expand clean energy access, RIPLE, our wholly owned renewable energy subsidiary signed a joint venture agreement to co-invest in a 20MW solar-hydro hybrid plant in Shiroro, Niger State. This project marks the first phase of a 300MW programme designed to scale renewable generation capacity over the next five years.

RIPLE has built a robust pipeline of projects spanning the renewable energy value chain, positioning itself as a catalyst in accelerating Nigeria's energy transition. Through strategic investments and targeted partnerships, RIPLE is driving scalable solutions that support energy access, decarbonisation, and long-term energy security for the country.



Another key green investment is Carbon Vista, an innovative carbon investment platform established by NSIA in partnership with Vitol. With an initial sponsor commitment of \$50 million, the platform is structured to mobilise institutional capital into high-integrity, socially impactful carbon avoidance and removal projects.

Carbon Vista targets both greenfield and brownfield opportunities across sectors such as transportation, agriculture, and energy. It is designed to build a diversified portfolio aligned with two core themes: Pure Carbon Play, where carbon credits are the primary income driver, and Carbon Plus, where carbon revenues are supplemented by income from infrastructure or asset-based investments. Structured as a Limited Partnership domiciled in Jersey, Carbon Vista reflects NSIA's ambition to create scalable market pathways for credible carbon finance while generating risk-adjusted returns for investors.

NSIA, in partnership with InfraCredit, has established a pioneering NGN10 billion Construction Finance Warehouse Facility (CFWF) to address the financing gap for sustainable greenfield infrastructure projects in Nigeria. Designed as a multi-funder revolving facility, the CFWF provides early-stage construction finance for eligible projects, which are later refinanced through InfraCredit-guaranteed long-term debt instruments in the domestic capital markets.

Through the CFWF;

- We advanced the VI Power initiative, a 30MW gasfired embedded generation plant in Victoria Island, Lagos. Designed to serve premium commercial consumers via Eko Electricity Distribution Plc., the project demonstrates our practical approach to addressing urban energy reliability through cleaner transitional energy sources.
- We funded the electrification of four underserved communities in Benue and Akwa Ibom through solar hybrid mini-grids and supported TSL Logistics' acquisition of Compressed Natural Gas (CNG) trucks to reduce emissions.

In 2023, NSIA became a signatory to the UN Principles for Responsible Investment (PRI), reinforcing our alignment with global ESG standards. This milestone formalises our alignment with global standards for responsible investment and reinforces our long-term approach to integrating environmental, social, and governance considerations into capital allocation.

Beyond these green investments, NSIA embeds ESG tenets across all sectors, exemplifying its role in shaping Nigeria's sustainable development pathway through purposeful capital deployment and partnership-driven innovation



Launch of the Green Guarantee Company (GGC)

In a landmark step toward accelerating climate finance in developing markets, NSIA co-established the Green Guarantee Company (GGC); the world's first climate-focused guarantee company. Unveiled at the London Stock Exchange, GGC is designed to unlock capital for green infrastructure by providing credit enhancement for investors purchasing green bonds and loans in emerging markets.



Managing Director and CEO of NSIA:

As a long-term investor of Nigeria's sovereign wealth, our strategy is underpinned by our adoption of sustainable investment opportunities that uphold environmental stewardship. Given the global urgency of positive climate action, our alignment with GGC will further expand access to climate adaptive solutions, particularly within emerging markets. This re-affirms our focus on creating shared value for the people and the planet."





GGC will provide pivotal support to enable issuers from developing countries to gain the financing they need to combat the impact of climate change on their populations, particularly the poorest. This support is critical as both increased fiscal pressure postpandemic and downward pressure of sovereign ratings of developing countries will limit their private sectors' access to global debt capital markets at a time when climate action is becoming increasingly urgent.



In 2024, we completed our inaugural carbon footprint assessment, establishing a baseline for emissions tracking.


The first phase of our carbon footprint assessment focused on NSIA's internal operations, identifying and quantifying direct and indirect emission sources within the organisation. The assessment applied emission factors and global warming potential (GWP) rates sourced primarily from the GHG Protocol and the Intergovernmental Panel on Climate Change (IPCC).



Total Emissions by Source








The next phase of the assessment will expand to include Scope 3 emissions from NSIA's portfolio companies. This will provide a more comprehensive understanding of the Authority's environmental footprint and inform portfolio-wide sustainability actions.

Beyond emissions tracking, NSIA is also open to exploring circular economy opportunities through practical waste-to-impact initiatives. In partnership with Chanja Datti and Waste Africa, a recycling program was launched within the Authority. In its pilot phase, 504 kilograms of waste—primarily plastic bottles and paper were recycled. Recycling proceeds funded tuition for three children, linking environmental action with social impact.



2024 Waste Collection Records (in kg)
















In a bid to reduce reliance on fossil fuel-based generators, MedServe partnered with RIPLE to implement solar energy solutions across its three centres (NLCC, NKDC, and NUDC). The solar project is expected to be completed in June of 2025.

These initiatives reinforce NSIA's commitment to embedding sustainability across its operations and investments—prioritising transparency, measurable impact, and continuous improvement.

While these limitations affect control over energy sources, lessons from the assessment are actively shaping the design of NSIA's new head office, slated for completion in 2027. The future facility will integrate energy efficiency principles from the ground up.

In the interim, the Authority has implemented several low-impact, high-effeciency operational changes:

Energy Consumption and Efficiency

NSIA continues to prioritise resource efficiency and climateconscious practices across its operations. Following the completion of its carbon footprint assessment in 2024, key recommendations centered on behavioral shifts to reduce energy consumption; particularly given the constraints of

- All lighting systems have been converted to LED bulbs, and internal protocols now require that air conditioning units be powered off by 8:00 p.m. daily.
- Staff are also encouraged to switch off lights and shut down computers when not in use to reduce unnecessary energy consumption.

In 2024, NSIA deepened its commitment to operational efficiency by embedding digital transformation into its core processes. The introduction of electronic memo and letterhead systems marked the beginning of a broader transition toward paperless operations. A dedicated Digital Transformation Team is spearheading this evolution, starting with digital sign-offs and document workflows to significantly reduce paper dependency.

A major milestone in this journey was the rollout of a fully digital procurement and vendor management system in Q1 2024. The system replaces manual, spreadsheet-based tracking with an end-to-end digital platform that supports vendor registration, bid invitations, evaluation, reporting,

and feedback. It is already integrated with the Corporate Affairs Commission database for real-time vendor verification, with additional integrations to the Federal Inland Revenue Service and global compliance tools such as World Check underway.

Lookingahead, NSIA plans to launchan open bidding model in 2025. This will expand access to procurement opportunities beyond pre-vetted vendors, promoting competitiveness, transparency, and inclusivity while reinforcing the Authority's commitment to sustainable governance and operational excellence.



NSIA ESG Week

In 2024, NSIA held its second annual ESG Week; an internal initiative aimed at strengthening awareness and embedding ESG principles across the Authority. The week-long series featured a dynamic mix of activities, including ESG and sustainability-focused trainings that provided staff with practical insights into NSIA's sustainability priorities and how these intersect with their day-to-day roles.



NSIA's Local Impact:

Through MedServe, NSIA is strengthening Nigeria's health systems with flagship projects like NSIA-LUTH Cancer Centre, NSIA-Kano Diagnostic Centre, and NSIA-Umuahia Diagnostic Centre, closing the healthcare access gap.

Sustainable Finance for Inclusive Development

Multilateral organisations and sovereign actors are using blended finance to attract private capital for public-good projects.

NSIA's Local Impact:

- Leveraging our expertise in sustainability and climate finance, NSIA is increasingly being recognised as custodians of Nigeria's evolving climate finance architecture. We are strategically positioning ourselves as a trusted channel for attracting and deploying global sustainable finance, aligning national priorities with emerging international climate funding opportunities.
- NSIA has become a credible player in blended finance, de-risking national priorities, creating investable climate infrastructure, and catalysing private sector participation in development finance, through the setup of platforms such as the Green Guarantee Company, InfraCredit, the Construction Finance Warehouse Facility and the Joint Project Preparatory Facility.

Carbon Markets and Nature-Based Finance

Carbon markets are expanding globally, with new voluntary and compliance mechanisms opening up green finance for emerging economies.

Nature-based solutions (NbS) are gaining traction as scalable, cost-effective climate and biodiversity interventions.
